


Processmodell of Littoralisation sensu Claudio Zucca and Veronica Colombo


„*Californisation*“ = « Housing is going into the Green »

Nobelprice for Literature 1962, listed in Le Monde's 100 Books of the Century,

This is the story of the emigration to California which was forced upon a group of people from Oklahoma through unemployment and abuse of power. „Original Geographical Definition of Californisation“

„Broadly speaking, the higher the national income per caput the more intensiv and specialised the Farming; thus the countries of the Mediterranean type-climates may be ranked roughly in an ascending scale: North Africa, the Levant, the Balkans, Chile, the North West Mediterranean basin, Western Australie, the South West Cape and Californie. Some authors have recently written of the Californisation of Bas – Languedoc. It could be argued that all Mediterranean-type countries aspire to the type of farming found in that state“ Grigg, D.B. „Californisation“ a definition of Agricultural Geography to describe the process towards a highly mechanised, (capital intensive) farming system, with a very high efficiency and productivity.

(Sub) Urban Sprawl into the „wild“ /



But also sometimes : progression of the wild into
„Urban area“

- In Suisse Romande/Swiss French (Vaud, Geneva) it is used in official spatial planning to describe the „uncontrolled urban sprawling“ around the „Lake Geneva“ and the „Pays de Gex“.
- In the ecological movement of mediterranean France to designate the uncontrolled urban Sprawl, suburban Sprawl, - the progression of individual residences (houses) into the Wild (Garrigues, Maquis, Forêt)
- In the (mediterranean) French Fire Fighting „Jargon“ – individuel house, residences, settlements scattered into the wild (Garrigues, Maquis, Forêt) which makes „fire fighting“ of „wildfires“ very difficult due to fragmentation of fire fighters (obligation to protect human life & houses)





Fire fighters combating Forest Fires along a continuous defense-line



Fragmentation of Fire fighters due to Californisation













Historical Landcover Change on the Leucate Peninsula





Change in proportion of land user types on the Plateau de Leucate, 1942-2008




